Waste Management will remove the dumpster and return it to the property at 62 Strawberry Lane. If issues persist DLPOA will notify the property owner that they cannot use DLPOA property for their dumpster storage or access.

 - 3) The trail next to 77 Dapplegray. The general plan is to fill these heavily eroded areas with as much soil as possible to build them back up before the rainy season comes again. Mike Goldsmith to help address.
